#### Notice of the Annual General Meeting and an Extraordinary General Meeting

In accordance with Articles 10 and 11 of the Statutes, the 2015 Annual General Meeting is called for Sunday the 28th of December 2014 at 1800, in the Eric et Sylvie Boissonnas Auditorium, Flaine-Forêt. Doors open at 1700.

An Extraordinary General Meeting is called for 1900 at the same place to vote on a proposal to amend the Statutes of Association to allow members to be called to General Meetings by email and by means of the Internet/

In case the AGM is not quorate an Extraordinary General Meeting is called for 1830 at the same place to cover all items on the original agenda.
